PURPOSE:

To acknowledge the Lochbuie Sewer Board's approved increase in sewer rates and fees for 2018. This item is presented to council purely for their awareness and consent based on Counsel's recommendation. There will be no specifically corresponding rate adjustment for existing City of Brighton Citizens.

BACKGROUND/HISTORY:

The 2018 rate increases were adopted by the Lochbuie Sewer Board at their November 30, 2017, meeting, and will become effective, January 1, 2018.

The approved 2018 PIF fee increases will not affect existing customers, as connection fees are paid for new connections only. The approved rate increase is 10.02%, which can be accommodated under the recently-approved 2018 Utilities budget.

BUDGET IMPACT:
