PURPOSE

Requesting City Council approval of a formal solicitation for the Sister Cities Park Restroom Project to the most responsive and responsible bidder, and approving the resolution giving the Mayor authority to sign the contract. Municipal Code Section 3.08.090, ". . . . All bids and proposals in excess of \$50,000 shall be awarded through formal written procedures by the city council."

BACKGROUND

The Sister Cities Park has never had a restroom within the park. Neighbors and users of the park have expressed the need for a restroom. This project will fulfill the need to have a waterless toilet placed within the park.
