The Parks and Recreation Advisory Board held a public meeting on October 3, 2018 to solicit additional input on the proposed name. At the Park and Recreation Advisory Board meeting on October 3, 2018, the Board unanimously approved a motion to recommend to the City Council that the Community Park be named the "Venture Park".
