A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACCEPTING THE PROPOSAL OF RIVER NORTH TRANSIT, LLC AND APPROVING THE PROCUREMENT OF THE MICRO-TRANSIT ON DEMAND SHARED RIDE SERVICE FOR THE CONTRACT AMOUNT OF EIGHT HUNDRED THOUSAND DOLLARS (\$800,000), AND AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE CONTRACT ON BEHALF OF THE CITY

WHEREAS, the City of Brighton (the "City") desires to provide supplemental transit services aimed at improving mobility and access for residents and businesses within the City (the "Services"); and

WHEREAS, the City and the Regional Transportation District ("RTD") are partnering to provide the Services, and RTD has awarded a grant to the City in the total amount of \$1,800,000 towards the Services, to be disbursed annually to the City through 2027 in the amount of \$600,000 (the "Grant"); and

WHEREAS, pursuant to the requirements of the Grant, the City will contribute \$200,000 annually towards the Services; and

WHEREAS, Article 3-8 of the Brighton Municipal Code sets forth the requirements and procedures for purchasing supplies and contracting for professional services; and

WHEREAS, the City published a notice inviting bids through its formal bid process for the Services; and

WHEREAS, River North Transit, LLC ("River North") submitted a proposal to complete the Services for the contract amount of \$800,000 per year (the "Proposal"); and

WHEREAS, sufficient appropriations exist for the Proposal; and

WHEREAS, the City Council believes River North is the most responsive and responsible bidder to perform the Services.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, AS FOLLOWS:

<u>Section 1</u>. The proposal of River North is hereby accepted.

<u>Section 2</u>. The City Manager, or designee, after consultation with the City Attorney, is hereby authorized to sign the contract in an amount of \$800,000 for the Services with River North on behalf of the City. Subject to sufficient appropriation in future budget years, the City Manager is further authorized to renew the contract annually in an amount not to exceed \$800,000.

Section 3. This Resolution is effective as of the date of its adoption.
