

## Capital Improvement Plan Overview

The Integrated Capital Project List is a list of the multimodal capital projects that would be required to achieve the build-out networks described in the 2016 Brighton Transportation Master Plan. It represents a coordinated approach to CIP planning that integrates multiple City departments, including street and active transportation projects with street rights-of-way, as well as components of the City of Brighton Trails and Open Space Plan. Successful completion of transportation capital projects requires that the entire project development cycle be planned and funded, from project concept planning, through project design, right of way acquisition, bid letting and construction management. The project list provides estimates for each of these phases in project development, not just the actual construction phase. This approach to planning and budgeting will ensure a logical and systematic progression of project development activities based on a multi-year capital plan.

The City will update this Integrated Capital Project List annually, taking into account the strategic priorities and benchmarks, as well as financial realities and funding limitations. Projects may be split or combined in the future based on funding, specific mobility needs or other opportunities. Prioritization of projects is based on existing and anticipated future growth. All planning level cost estimates assume full build-out of the given corridor. However, in some cases the full build-out of a project may not be needed, which would result in cost savings. Projects in this list are organized by street corridor, regional trail corridor and programmatic elements.

**No.**  
Project number. Projects are organized by corridor. The number indicates the corridor and the letter indicates the project segment within that corridor.

**Mode**  
S = Streets Projects. Includes active transportation elements that would be built as part of a new or upgraded street corridor (i.e. sidewalks, crosswalks multiuse trails parallel to arterial streets).  
AT = Active Transportation only projects. Includes projects that only address the active transportation network.

Name of the corridor.

Street widening/ improvement - existing paved street exists and would be improved and possibly widened  
Pave and grade - existing dirt road would be paved and improved to new standards  
New street construction - no existing street exists, new street construction would be required

Pavement markings, signage - street would be restriped to add sharrows and other treatments as necessary including signs to guide road users  
Street restriping, signage - street would be restriped to add bicycle lanes and other treatments as necessary including signs to guide road users  
New trail construction - new multi-use trail would be added including marked street crossings  
Spot improvement - Includes unique road and/or trail improvements, typically at an intersection  
Study - transportation related planning study  
Annual allocation - annual citywide program with allocated funding

- Immediate - project to be implemented by year 2020
- Near term - project to be implemented by year 2025

**Year**

- Proj. dev. - year (if known) that project development would be initiated (engineering, planning, ROW acquisition, etc.)
- Const. - year (if known) that construction would begin

**Impact Fee**

- Y - Project qualifies for funding from the City's transportation impact fee
- N - Project does not qualify for funding from the City's transportation impact fee

- Planning Level - Total estimated cost of the project based on planning level knowledge (includes engineering work, contingency, ROW acquisition and construction)

**Planning Level Cost Estimates**

- Linear foot - planning level estimated construction cost per linear foot (see Cost Estimate Key)
- Concept Design - planning level estimated cost to complete conceptual engineering (30%), typically 3% of construction costs
- Final Design - planning level estimated cost to complete final design/ engineering (100%), typically 5% of construction costs
- ROW - estimated cost to purchase right-of-way if known
- Construction - planning level estimated cost of project construction, typically estimated by multiplying the cost per linear foot by estimated linear feet of project
- Contingency- planning level estimated contingency for project, 20% of estimated construction cost
- CE - planning level estimated cost of construction engineering, typically 1% of construction costs

**Conceptual Design Cost Estimates**

- Final Design - estimated cost to complete final design/ engineering (100%) based on conceptual design work
- ROW - estimated cost to purchase right-of-way if known
- Construction - estimated cost of project construction based on conceptual design work
- Contingency- estimated contingency for project based on conceptual design work, typically 15-20% of estimated construction cost
- CE - estimated cost of construction engineering based on conceptual engineering work

**Final/ Pre-Bid Cost Estimates**

- Construction - estimated cost of project construction based on final design work
- Contingency - estimated contingency for project based on final design work, typically 10-15% of estimated construction cost
- CE - estimated cost of construction engineering based on final design work

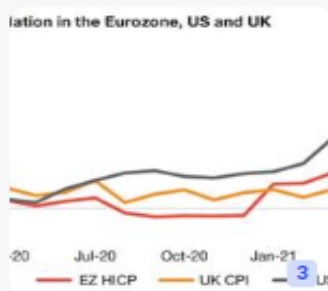

- **2022:** 6.5%
- **2023:** 3.4%
- **2024 (up to February):** 3.2% <sup>1</sup>
