

RESOLUTION NO. 2025-02

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, ACCEPTING THE PROPOSAL OF ASPHALT SPECIALTIES CO., INC. AND APPROVING THE PROCUREMENT OF THE 4<sup>TH</sup> AVENUE RECONSTRUCTION PROJECT FOR THE CONTRACT AMOUNT OF ONE MILLION FIVE HUNDRED FIFTY-EIGHT THOUSAND EIGHT HUNDRED SEVENTEEN DOLLARS (\$1,558,817), AND AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE CONTRACT ON BEHALF OF THE CITY

WHEREAS, the City of Brighton, Colorado (the "City") is currently installing a water line along 4<sup>th</sup> Avenue from Skeel Street to Bromley Lane; and

WHEREAS, after installation of the water line, the City desires to reconstruct that segment of 4<sup>th</sup> Avenue from Skeel Street to Bromley Lane by increasing the thickness of the asphalt to carry the increased traffic loading and volumes, along with restoring the surface disturbed by the water line installation; and

WHEREAS, the City published a notice inviting bids through its formal bid process for the 4<sup>th</sup> Avenue Reconstruction Project, Project #24-008664 (the "Project"); and

WHEREAS, sufficient appropriations exist for the Project; and

WHEREAS, Asphalt Specialties Co., Inc. ("ASC") submitted a bid for the Project in the amount of \$1,558,817 (the "Proposal"); and

WHEREAS, Article 3-8 of the Brighton Municipal Code sets forth the requirements and procedures for purchasing supplies or services and contracting for public works or professional services; and

WHEREAS, the City Council believes ASC is the most responsive and responsible bidder for the Project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, AS FOLLOWS:

Section 1. The Proposal of ASC is hereby accepted.

Section 2. The City Manager, or designee, after consultation with the City Attorney and making any modifications or deletions recommended, is hereby authorized to sign the contract for the Project with ASC on behalf of the City.

Section 3. This Resolution is effective as of the date of its adoption.
