A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, APPROVING THE SECOND AMENDMENT TO THE INTERGOVERNMENTAL AGREEMENT WITH THE URBAN DRAINAGE AND FLOOD CONTROL DISTRICT FOR SABLE BOULEVARD OUTFALL CHANNEL IMPROVEMENTS AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SECOND AMENDMENT

WHEREAS, pursuant to § 29-1-203 *et seq.* of the Colorado Revised Statutes, governmental entities are authorized and encouraged to cooperate or contract with one another to provide any function, service, or facility and to share in the costs of services or functions for their mutual benefit; and

WHEREAS, pursuant to Resolution 2025-91, approved by the City Council on December 16, 2025, the City of Brighton ("City") and the Urban Drainage and Flood Control District, doing business as the Mile High Flood District (the "District"), entered into an intergovernmental agreement for the design and construction of drainage and flood control improvements for the Sable Boulevard outfall channel located at 144th Avenue, which are necessary to provide efficient stormwater drainage in that area (the "Agreement"); and

WHEREAS, pursuant to Resolution 2026-27, approved by the City Council on March 3, 2026, the parties amended the Agreement to allocate additional funds for the design and construction of the drainage and flood control improvements; and

WHEREAS, the City and District desire to again amend the Agreement to allocate additional funds for the design and construction of the drainage and flood control improvements (the "Second Amendment"); and

WHEREAS, the drainage and flood control improvements are necessary for the health, safety, and welfare of the residents of the City and surrounding area and will benefit residents of the City by preventing damage and loss due to flooding, and the funds to be contributed by the City have been appropriated in the 2026 budget.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Brighton, Colorado, as follows:

Section 1. The Second Amendment is hereby approved.

Section 2. The City Manager is hereby authorized to execute the Second Amendment on behalf of the City in substantially the form presented at this meeting, with such technical additions, deletions, or variations as the City Attorney may deem necessary or appropriate and not inconsistent with this Resolution, and to undertake such actions as may be necessary to finalize said Agreement, and any amendments thereof, on behalf of the City.

Section 3. This Resolution is effective as of the date of its adoption.
