

RESOLUTION NO. 2025-63

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, APPROVING AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF BRIGHTON, COLORADO AND THE E-470 PUBLIC HIGHWAY AUTHORITY, AUTHORIZING THE CITY MANAGER TO EXECUTE THE AGREEMENT ON BEHALF OF THE CITY AND TO UNDERTAKE SUCH TASKS AND EXECUTE SUCH DOCUMENTS AS MAY BE REQUIRED TO IMPLEMENT SAID INTERGOVERNMENTAL AGREEMENT ON BEHALF OF THE CITY

WHEREAS, the City of Brighton, Colorado (the "City") and the E-470 Public Highway Authority ("E-470") desire to enter into an Intergovernmental Agreement ("IGA") regarding the ownership and maintenance responsibilities for new infrastructure associated with the construction of new service ramps connecting the E-470 Toll Road to Sable Boulevard; and

WHEREAS, the IGA will provide long-term clarity and foster cooperation between the City and E-470 in maintaining infrastructure that supports regional mobility and economic development; and

WHEREAS, the City Public Works Department will assume maintenance responsibilities for specified infrastructure within the City's jurisdiction; and

WHEREAS, the City's assumption of such maintenance responsibilities has been anticipated, and the associated costs have been considered in the City's long-term capital planning; and

WHEREAS, the City Council finds and determines that the terms of the IGA are reasonable, that this IGA exemplifies the spirit of cooperation between the City and E-470, and that it is in the best interests of the residents of the City that the IGA be approved; and

WHEREAS, Section 18(2)(a) of Article XIV of the Colorado Constitution and Section 29-1-201, et seq. of the Colorado Revised Statutes authorize and encourage local governmental entities to cooperate by contracting with one another for their mutual benefit.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BRIGHTON, COLORADO, AS FOLLOWS:

Section 1. The IGA between the City and E-470 is hereby approved.

Section 2. The City Manager is hereby authorized to execute said IGA on behalf of the City and to undertake such tasks and execute such documents as may be required to implement said IGA on behalf of the City.

Section 3. This Resolution is effective as of the date of its adoption.
