I hope you're doing well. I am writing to express concerns regarding the upcoming City Council meeting scheduled for tomorrow, 3/4/2025, at 6:00 p.m., where the Singh property rezoning application is to be discussed.

Improper Signage/Notice

- **For several days, the required notification sign on the subject property has been lying on the ground, making it unviewable to passing traffic on 120th ave.**
- **As you know, the City's ordinances require clear and conspicuous signage to inform the public of pending land use and zoning matters. Because the sign has not been properly displayed, many residents may not realize that the City Council meeting is imminent.**
- **I have attached several photos displaying such.**

Request to Delay Meeting

- **Several neighbors have reached out to me indicating they cannot attend the meeting due to unforeseen circumstances such as surgery or unplanned work travel.**
- **It would be helpful, in the interest of public participation and fairness, if the City Council meeting could be postponed so that affected residents have a meaningful opportunity to comment and engage.**
- **My understanding is that in a previous instance, the applicant was granted a delay based on personal reasons. Given that multiple residents now face legitimate scheduling conflicts—and bearing in mind the improper signage—it seems equitable to extend the same courtesy and reschedule the meeting.**

Could you please let me know the City's position on ensuring the sign is fixed and publicly visible for the appropriate amount of time, as well as the procedure for

requesting a continuance or delay of the upcoming City Council meeting?

Please include this correspondence and attachments to the public record for tomorrow's meeting, and for any future meetings regarding the Singh property rezoning application(s).
