Hello Summer McCann,

I am writing to inform you that I, Greta Finlay, did not receive notice of the neighborhood meeting regarding the proposed zoning change for the property located at 13767 E. 120th Ave, Brighton Colorado, 80601. The notice was incorrectly addressed with the wrong ZIP code, resulting in non-delivery and a return to the original sender. My neighbor Hector Marquez, whose property also directly adjoins the property located at 13767 E. 120th Ave, did not receive a neighborhood meeting notice either because his address also had the wrong zip code. I am aware that my daughter, Natalija Finlay, has already brought this lack of notice to your attention, however, I would also like you to include this email and my statement in the official record.

I am also concerned that the neighborhood meeting held on May 3rd, 2024, presented only the applicants' intent to seek a combination of MU Residential and limited C-2 zoning. Following that meeting, however, the applicants altered their plans and zoning amendment application to request C-2 zoning across the entire site. This is a material and substantive change, yet no additional or follow-up neighborhood meeting was held to address the change, and no notice of the different or revised application was provided to affected property owners.

These notice errors raise concerns regarding due process and transparency.
