How Issue 1A Will Help the City of Brighton with its Housing Goals, and Strengthen Cradle-to-Career Success and Economic Prosperity



THE OPPORTUNITY

Access to housing that is affordable is crucial to helping young people achieve critical cradle-to-career outcomes, and strengthening economic prosperity in the north metro region.

In 2023, the City of Brighton boldly <u>set a goal</u> to develop 134 new affordable housing units by 2026 as part of Proposition 123, marking its commitment around this critical priority. **Adams**County Ballot Issue 1A will help address the housing affordability crisis currently threatening Brighton families, our workforce, and the long-term success of this region.

THE CHALLENGE

- Adams County faces a 10,000 home deficit, projected to reach 30,000 by 2050

Education

- Reduces school dropouts and improves attendance
- Enhances focus on learning instead of housing instability

ISSUE 1A: HOUSING AFFORDABILITY

IMPACT ON SALES TAX



Issue 1A **only asks for a small 0.15% sales tax increase**—that's just 15 cents on a \$100 purchase. This minimal increase will have a big impact on housing affordability.

In fact, Brighton's sales tax will only increase from 8.50% to 8.65%, **which will still remain lower than surrounding localities** including Bennett, Commerce City, Federal Heights, Lochbuie, Northglenn, and Westminster.

- Adams County's current sales tax rate is 0.75% (75 cents on every \$100)
- This rate has stayed the same since 2007, even though our population has grown by 28% (~118K more people) and our community's needs have evolved
